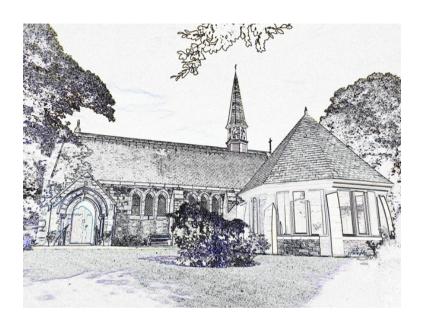

Shared Ministry Development Team: Partnership for Missional Church

In March last year we began a threeyear programme called Partnership for Missional Church. Its purpose is to find out how God is working in our wider local community and help us to see how we can contribute to this work.

Since we started, the Steering Team have collected a wide range of data about our church, including trends in church attendance, how we use our funds, our buildings etc. We have also looked at comparative demographic data about our local community, for example different types of housing, census information and deprivation data.

In order to find out what people think is important and what concerns them about our village, the Listening Team sampled the views of people connected with our congregation and talked to twelve local people who live and/or work in Cleadon, but are not directly connected with church.

Alongside the data collection we have also tried out two new spiritual practices, "Dwelling in the Word" and "Seeking God's Way Together."

In May we had great fun sharing stories of our shared history and thinking about our hopes for the future at the "Stories of All Saints" afternoon (where we also had lots of lovely cake).

With the PCC the Steering Team are now preparing for the second year of the programme. During the coming year we are hoping to find God at work in the community by finding partners and trying out some activities to respond to the question "How might we catalyse the existing community groups to create a contemporary heart in a flourishing Cleadon."

Minutes of 2019 Vestry Meeting and APCM

The Vestry Meeting and Annual Parochial Church Meeting were held in church on Sunday 3rd March 2019, and opened after the Gospel reading in the 10am Eucharist. 47 people attended. The Rev'd Vernon Cuthbert chaired the meeting.

Vestry Meeting

1. The minutes of the Vestry Meeting for 2018

The minutes were approved.

2. The Churchwardens' Report for 2018

The Church Wardens' report was received: there were no questions. Brian Peel and Marie Philpott were thanked for their hard work during the year. Brian had indicated his intention to step down from the role, and was thanked especially for his work relating the repairs to the spire.

3. Election of Churchwardens for 2019

Marie Philpott and Jenny Grant were elected as Church Wardens for the forthcoming year. The congregation was reminded that the role of a churchwarden is to make sure that tasks are completed, not to do everything themselves.

This concluded the Vestry Meeting.

Annual Parochial Church Meeting

- 1. **The minutes of the APCM for 2018** The minutes were approved.
- 2. Reports of the PCC for 2018, previously circulated within the Annual Report. All were accepted, with the following additional comment: The Electoral Roll now had 93 members (following some additions since the report was printed showing 84)
 - The Treasurer's Report and Accounts for 2018 had been previously circulated and were received. The excess of expenditure over income was noted, a cause for concern as the congregation is getting smaller in number, while costs are increasing.
- Group reports were received. There were no comments or questions
- 4. Elections to the PCC for 2019.

There were 3 vacancies for 3 years, and 1 vacancy for 1 year. Anne Hudson was elected onto the PCC. It was hoped that the other vacancies would be filled in the near future.

- Appointment of Sidespeople
 In accordance with previous practice it was agreed that these people would be appointed by the churchwardens.
- 6. Appointment of Independent Examiner for 2019

The 2018 accounts had been independently examined by Mr Peter Calvert, who is willing to continue in this role. Mr Calvert was therefore appointed as Independent Examiner for 2019.

Gift Aid

Sadly, Carol Casey had to relinquish her role as our Gift Aid Secretary during the year due to ill health. We are grateful to her for her diligence in carrying out this work over the years.

Due to the slow take-up of the 'Parish Giving Scheme' during the latter part of 2019 it has proved difficult to gather upto-date figures on the number of church members currently giving using Gift Aid. The 'Parish Giving Scheme' is a PCC- & Diocese-supported initiative to reduce the burden of cash-counting, recording, & banking for our people. Gift Aid is claimed on our behalf by the scheme administrators and returned to the parish once it has been received from HMRC.

Anyone not wishing to join the scheme can remain on the weekly envelope donation or standing order scheme, from which Gift Aid is claimed in the usual way. However, the PCC recommends the scheme as we look to the future and embrace more efficient ways of working using modern technology.

Health and Safety

During 2019 I undertook specific risk assessments in the church, church grounds, parish hall, chapter house, kitchen, office, corridors, toilets, Old School Room, church gardens and the first aid boxes.

The car park is in need of a facelift after the building work to the Old School Room. This will be undertaken by volunteers, when it is safe and convenient, there are no timescales for this work.

Health and Safety is everyone's responsibility and any issues that you feel are relevant should be reported. If anyone is unhappy with anything untoward these will be looked into as soon as possible and rectified accordingly

Friends of All Saints

The membership of the Friends at the start of 2019 was 87 adults and 9 children.

We purchased 580 copies of the Cleadon Courier at a cost of £290. These were distributed to our members in the village and some were posted to members further afield.

We continued to grow bedding plants and organic vegetables throughout this year, which together with homemade jams were sold in the church hall after the 10.00 am Sunday service. With the generosity of our congregation we were able to bank £104.40 into the Friends account. We hope to continue selling our produce throughout 2020.

The Friends organised a coach outing in September to Whalton Village Show where we all had a wonderful day out, with beautiful weather. This year a circus entertained everyone with Big Top, acrobats, jugglers and much more. There was an organ recital in the church. There were stalls selling homemade produce, honey, crafts, and country clothing, and there were classic cars on display, sheep racing and so much more to see, not forgetting the ice cream, and food stalls. We all came home tired, happy with lots of purchases. The £100 profit from Helen's stall went to help the Spire Fund.

During 2019 the Friends paid £390 for repairs to the cooker in the hall kitchen,

£156 to renew the lighting in the hall and £1,374 for insulation to the Old School Room ceiling once the repairs were underway.

Report of the PCC

for the year ended 31 December 2019

Administrative information

All Saints' Church is situated in Cleadon Lane, Cleadon, Sunderland, SR6 7UU. It is part of the Church of England's Diocese of Durham.

The correspondence address is c/o All Saints' Parish Hall, Sunderland Road, Cleadon, Sunderland SR6 7UR.

Aims and Purposes

The Parochial Church Council (PCC) has the responsibility of co-operating with the incumbent in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. It has responsibilities for the maintenance of the Church building, the Parish Hall and the Old School Room.

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community. Our services and worship put faith into practice through prayer and scripture, music and sacrament. In particular, we try to enable all people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the Gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Mission and outreach work.

To facilitate this work it is important that we maintain the fabric of the All Saints Church and its associated buildings.

Public Benefit

Our worship is open to all regardless of faith or affiliation. The resources available to the PCC are used to further its aims and purposes. The PCC takes as wide an interpretation of the 'whole mission of the Church' as possible to enable community use of its buildings, whilst retaining the right to not allow use that is contrary to this mission.

Structure, governance and management

The PCC is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure. The PCC is a registered charity No. 1132228 with the title "The Parochial Church Council of the Ecclesiastical Parish of All Saints Cleadon".

The method of appointment of PCC members is set out in the Church Representation Rules. All Church attendees are encouraged to register on the Electoral Roll and stand for election to the PCC.

Electoral Roll

2019 was the year when everyone was required to re-apply for inclusion on the new Electoral Roll.

By December 31st our roll comprised 32 men and 68 women, making a total of 100 of whom 73 live within the parish and 27 live outside the boundary.

Attendance

There were 92 communicants on Easter Day from 112 worshipers. On Christmas Eve and Christmas Day 349 people attended services of which 41 took

with an estimated cost of about £70,000 including VAT. Fund-raising has been ongoing, with grant applications made and donations from individuals and groups enabling us to cover the cost and have an amount earmarked for further repair works on our buildings in the future. Grateful thanks are due to all the charities, groups, church members and friends who responded so magnificently to the appeal. The work was started in July, following approval of the faculty application, and finished at the end of November.

Following the car accident damage to the Old School Room in March our insurers, Ecclesiastical Insurance Group (EIG), became involved and agreed to meet the cost and arrange the repairs. These also started in July and were completed in November. The churchwardens have been very involved in overseeing both of these substantial repair works, for which we are very grateful.

There have been many on-going minor repair matters during the year, such as repairing emergency lights; clearing and repairing guttering; a new pump for the church heating etc. In addition, Walter Carr carries out lots of routine maintenance work involving plumbing, fixing, joinery, electrics, painting, clearing gutters and drains and patching up the car park surface. We are extremely grateful to him for this largely unseen work, which saves us a substantial amount of money.

The coverings on the stained-glass windows had been identified in the Quinquennial Inspection as being in need of replacement and an estimate has been received for this work, which is

necessary under the terms of our insurance.

Since completion of the work on the Old School Room, cracks appeared in the plaster and paintwork around the east wall window, possibly caused by a vehicle hitting the outside wall. Our insurance company has agreed to meet the cost of this repair, which will be carried out in 2020.

Social Committee

This included a 150th Anniversary Quiz with a pies and peas supper, afternoon tea after the Pilgrimage Walk and a Ceilidh using both halls just before the unfortunate demolition of the Old School Room.

Each event has been highly successful in many ways and we hope to continue the pattern in 2020. Our main aim is to create a venue for people to come and enjoy things together. Any ideas are

Finance and Property Group

Members during the year were Chairman Revd Vernon Cuthbert, Churchwardens Marie Philpott and Jenny Grant, Treasurer Helen Belsham, Gift Aid Secretary Carol Casey, Brian Peel, Bryan Saunders, Walter Carr and Keith Higgin. Brian Peel and Carol Casey resigned during the year. Claire Wood was appointed Gift Aid secretary at the end of the year.

We monitored income and expenditure and reviewed the statutory fees. A budget was prepared which showed a break-even position with Parish Share at £48,516, although we were only able to pay £36,387 as at the end of December.

In July we joined the Parish Giving Scheme, by which members offer their donations by direct debit each month, with the scheme also claiming the Gift Aid each month and remitting the amounts to our bank account. Fourteen people had joined at the end of the year, with several others still considering joining.

In January the PCC welcomed back Revd Vernon after his sabbatical the previous autumn and expressed gratitude to those who had helped to hold the fort in his absence, especially Marie and Brian the churchwardens.

2019 was the 150th anniversary of All Saints and was marked by a number of celebrations throughout the year. In supporting these and other plans for the year, the PCC noted the need for more people to come forward to help, especially to fill gaps left by those who, having given their time and talent faithfully over many years, were now no longer able to continue.

Repairs to the church spire occupied a good deal of PCC time throughout the year, and the car accident in March, resulting in the need for further repairs to the Old School Room, added to the workload. Tough decisions had to be made to enable this work to be financed: the PCC agreed to hold back payments of the Parish Share temporarily, should this be necessary. At its September meeting the PCC was able to pause its proceedings to give thanks to God that the repair funding target had been met, and to record thanks to individuals whose hard work had made this possible.

In May the PCC adopted a set of Safeguarding policies and other documents provided by the Diocese, emphasising the importance of safeguarding in the life of the church. Sadly, however, a vacancy for a Safeguarding Officer remained unfilled throughout the year.

In June the PCC considered and approved the draft Deanery Plan, which identified the limited funds for stipends in the Deanery, and the need for us to share a priest with Whitburn parish. Discussions about how this might work continued at later meetings, and the churchwardens were charged with meeting their counterparts in Whitburn to help prepare the way.

Financial information is reported in detail elsewhere, but an element of finance considered and endorsed by the whole PCC in July was the Parish Giving Scheme, in which church members would be encouraged to give to the church by Direct Debit rather than other means. This would significantly reduce the work of those who count, record, and bank cash or envelopes given on the plate.

Throughout the year the PCC received regular updates on the progress of 'Partnership for Missional Church', reported on elsewhere in this Annual Report. 'Dwelling in the Word' took place at each PCC meeting, and PCC members attended a 'cluster group' meeting in November.

The **Standing Committee** consists of the Priest-in-charge, the Churchwardens, and the Vice Chairman, Hon. Treasurer and Hon. Secretary of the PCC. It meets on an occasional basis when urgent business needs to be transacted by the PCC.

As is the local custom, appointments to the role of sidesperson was deferred to the church wardens.

Churchwardens' Report for 2019

2019 was the 150th anniversary of All Saints Church and we marked the occasion with several events. The actual dedication of the church was 31/03/1869 and this anniversary was celebrated by a visit from the Bishop of Durham who preached at our Mothering Sunday service and planted a rowan tree as a commemoration. Other events included a quiz, a ceilidh and a pilgrimage from the mother church at Whitburn to Cleadon. In May we developed a timeline as part of PMC which helped us to celebrate the history of the church and church family.

During Lent we held a course developed by the diocese, focusing on how we journey with God, which led up to the diocesan Waymark conference in October, attended by Vernon and Jenny Grant.

In March there was major damage to the Old School Room (OSR), so throughout the summer we had builders working on the OSR and the planned repair to the church spire. We were happy to see both projects completed in the autumn. The Mayor of South Tyneside came to re-open the OSR in December. We are very grateful for all the grants and individual donations which enabled us to pay for the work on the spire.

At the 2019 APCM Marie Philpott was reelected and Jenny Grant joined her as churchwarden. During the year the churchwardens have continued to meet with the vicar on a regular basis and have also begun talks with the Whitburn churchwardens about sharing a priest in accordance with the new deanery plan.

Pupils from Cleadon CofE Academy were welcomed for Experience Easter and Experience Christmas and also held their own harvest service, nativity and end of term services in church.

This year we marked the "Thy Kingdom Come" week of prayer with a 24 hour prayer vigil in church which was enjoyed by all who participated.

As part of our Christmas celebrations we held a crib festival in church and organised a nativity trail around the village. We were delighted that the Bishop of Durham returned to take part in our Christingle service.

We use the seasonal booklets from Sunday's 10am service unless outside of the seasons (Ordinary time if it is not Advent, Christmas, Epiphany, Lent, or Eastertide) when a booklet specifically for midweek worship is used.

On some 1st Thursdays of the month our congregation is swelled by members of the Mothers' Union. There are opportunities for the set Bible readings to be read by those attending.

Support Activities

Coffee

We are still using ground coffee on Sunday mornings and this is generally appreciated. It is however necessary to prepare well in advance of the morning service, at about 9.30am, to make up several flasks ready for the congregation when they come down to the Old School Room. Even so it is not unusual to make up further quantities to meet demand. Recently we have started to use ground coffee on Saturday mornings also.

Over the past year (2019) the sum of £850.16 has been raised for church funds on Sunday mornings. With six church coffee mornings in 2019 on Saturday, the amount raised was £854.00. This brings the total annual revenue generated by the operation for 2019 to £1704.16

During the eleven years that I have been responsible for this enterprise the number of voluntary helpers has gradually reduced. Like most such activities at the present time we need additional staff, particularly for Sunday Coffee, either male or female over 18 years of age. Once more this problem really is cause for concern and it would be nice to see some new people on the teams.

In closing I would like to thank all team members, and other volunteers, who make and serve refreshments for Saturday coffee mornings and on Sundays after 10.00 am worship. Also the Cubs/Scouts who often arrange the tables and chairs for coffee mornings after their meeting on Friday evenings, thus enabling them to be prepared

At present Edna Nichol and Jean Higgin kindly provide two resources for help in preparing the prayers: Edna manages the rota of those who lead the intercessions and also provides a form of words that often links to the lectionary material used elsewhere in the service, while Jean provides the names of those for whom directed prayer is requested.

Additionally, throughout the last year a prayer for Partners in Missional Church and for the Waymark Conference have been included.

Allan Bailey compiles the list of readers for the 10am Sunday Service, and he gives each reader their own copy of the rota which includes the relevant Bible readings.

Rotas for Bible readings and intercessions are distributed well in advance, so that if necessary changes can be made.

Sadly, over the year some readers and intercessors have for various reasons been unable to carry on with this faithful service. Their contribution has given great encouragement to new members stepping into the role.

Deanery Synod Report

The main focus for the Synod in 2019 was the development of a new Deanery Plan, for implementation in 2020. The work was carried out with the help of Revd Canon Sheila Bamber, and given final approval by the Deanery Synod in November 2019. It sets out Jarrow Deanery's proposals for working with God to bless our communities in Jesus' name for the transformation of us all. It focuses on the three key Diocesan priorities of growing the church, engaging with children and young people and tackling poverty.

The new Plan sets out where we need to put our energies if we are to be a thriving Deanery: in worship, prayer, study of scriptures; in strengthening fellowship, discipleship and mutual support; and in looking outwards into the world sharing the good news of Jesus Christ. Twelve key priorities are identified to help us to achieve this.

It was important to recognise the limited resources available to us, particularly in the number of stipendiary priests across the Deanery. The plan allocates 10.5 clergy posts for Hebburn, Jarrow, South Shields, the Boldons, Cleadon and Whitburn, and brings the parishes of Cleadon and Whitburn under the ministry of the same priest. Our two parishes, whilst remaining separate, will be asked to find ways to work together and also in collaboration with the three Boldon parishes: worshipping and praying together, sharing skills and experience, with a co-ordinated approach to mission, offering generous support and enabling specific gifts.

The Plan proposes a change in how we work with the five church schools in the Deanery, moving towards a relationship where the Deanery as a whole supports, and is supported by, the church schools. We expect to see opportunities for shared prayer and community activity, and support for governance from across the Deanery.

The Plan aims to be realistic and achievable, recognising always that God calls us to do more than we can ever imagine, but never leaves us or forsakes us. Our Plan calls for a renewed vision and understanding of God's preferred and promised future for our Deanery.

This annual report was adopted by the PCC on 17/06/2020 and signed on their behalf by the Rev'd Vernon Cuthbert, PCC Chairman.



Financial Review

In accordance with the Charities Act 2011 and in particular the 5th Edition PCC Accountability, the Annual Accounts can be presented adopting the Receipts and Payments basis.

Voluntary receipts for Unrestricted funds were at a slightly lower level than in 2018 before Gift Aid claim. The Gift Aid secretary resigned in April and a successor was not appointed until December, so that no claim was able to be submitted from April 2019 until early 2020. Thus, Gift Aid received was only £5,608. Unrestricted income from other church activities was slightly higher and there were some 'one off' receipts. Total unrestricted income was therefore reduced by £7,038 at £79,591.

We were unable to meet our Parish Share pledge of £48,516, only paying £36,387 in respect of 2019, a shortfall of £12,129. There were reductions in Church running expenses and routine repairs to offset small increases in other headings. The end result shows total unrestricted expenditure was £17,203 lower at £75,959.

Because of the unpaid Parish Share, the overall result was a surplus of £3,632 on unrestricted funds. When the opening balances of £1,922 on current account and £3,275 on deposit account are added to this, we have total unrestricted funds of £8,829.

Much of the year was involved with the repair of the Church Spire and there was a very generous response to the appeal that was launched at the beginning of the year from individuals, groups and charities. The amount raised was sufficient to cover the costs of

£69,016.60 and a balance of £7,448 was able to be put into a Repair Fund towards the cost of other repair and maintenance work that is needing to be done to our buildings. Some of this was used at the end of the year. The Spire repair was completed at the end of November.

Substantial repairs were also required to the Old School Room following the damage caused by the vehicle collision. This was, fortunately, covered by our insurers Ecclesiastical Insurance Group and this work was mostly completed by the end of the year.

Reserves Policy

It is PCC policy to endeavour to maintain a balance on unrestricted funds equivalent to 3 months unrestricted payments, to cover cash flow and emergency situations that may arise. The balance of £11,070.63 on unrestricted funds at the year end, which includes the Friends accounts, is below this requirement. The separate fund balances are set out within the Statement of Assets and Liabilities.

Investment Policy

It is our policy to invest surplus fund balances with the Central Board of Finance Church of England Deposit account. Smith, from the Bread of Life Food Bank.

In September, at the Network Get-Together, Jane Cook thanked the members who continue to deliver Congratulations, Welcome, "Thinking of You" cards, Christmas and Easter cards. She quoted John Wesley, who said "Watch over another with love". Prayers were said in both churches on Pastoral Sunday. We have recruited five new Networkers.

The group assisted at twelve baptisms. Jean visited the families beforehand. Ellen delivered anniversary cards. We also sent 50 invitations for the Christingle and Christmas family services.

Ten gifts of hyacinth bulbs were delivered to the needy at Christmas, kindly planted by George Wilson. Val sent bereavement cards and Linda sent wedding anniversary cards.

We also value the pastoral care that individual church members give. Together, by showing our love for others, we hope we can witness to God's love for everyone.

Children's Society.

Notes to the financial statements

For the year ended 31st December 2019

Accounting Policies

The financial statements have been prepared in accordance with the Charities Act 2011 and the PCC, 5th Edition. The Charities Act 2011 is a consolidation of previous Acts but did not introduce new legislation.

The financial statements have been prepared on a receipts and payments basis and under the historical cost convention. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

Funds

Endowment Funds are funds, the capital of which must be maintained; only income arising from investments of the endowment may be used either as restricted or unrestricted funds depending upon the purpose for which the endowment was established.

Restricted funds represent (a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest, and (b) donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund. The PCC does not usually invest separately for each fund.

Unrestricted funds are general funds which can be used for PCC ordinary purposes.

Incoming resources

Planned giving, collections and donations are recognised when received. Grants and legacies are accounted for when the PCC receives the amounts due. All other income is

recognised when it is received. All incoming resources are accounted for gross.

Resources expended

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The diocesan parish share is accounted for when due. Amounts received specifically for mission are dealt with as restricted funds. All other expenditure is generally recognised when it is incurred and is accounted for gross.

Assets Retained for Church Use

Consecrated and benefice property is not included in the accounts in accordance with the Charities Act 2011.

Movable church furnishings held by the vicar and churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the church's inventory, which can be inspected at any reasonable time. For anything acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements. Subsequently no individual item has cost more than £5,000 so all such expenditure has been written off when incurred.

Equipment used within the church premises is depreciated on a straight-line basis over four years. Individual items of equipment with a purchase price of £1,000 or less are written off when the asset is acquired.

Cleadon Church of England Academy

This year, instead of reporting on some of the highlights of our year, I would like to share with you an aspect of Academy life that is a growing concern: that of the mental health of our children and families.

Lifestyles and expectations of both children and adults have changed greatly over the last few decades, leading to increased pressures and anxieties. Mental health is a priority across the Academy, and is an aspect we are continually developing. Here are a few of the strategies we employ:

This year we marked World Mental Health Day with age-appropriate lessons and videos about feelings, being kind and looking after our mental health. Children are encouraged to discuss their worries and concerns, supported by the use of Worry Monsters (where children 'post' their concerns) in each classroom.

'Relax Kids' is a commercial programme delivered twice a year in school, in which pupils learn a little more about relaxation and mindfulness, as well as how to recognise strong emotions. We have had very positive feedback from pupils who have participated in this scheme. We also organised some 'Relax Kids' Training for parents, which gave parents a range of strategies to support the mental health of their children at home.

A trainee counsellor has a once-weekly placement in school to give individual support to pupils. Two of our teachers are trained Mental Health Champions, a 'first port of call' for children with emotional difficulties, who can signpost children and parents to further help and support, or refer them on to Mental Health Services if appropriate.

One of the Academy's values is about showing respect, promoting the wellbeing of all its members. The initiatives detailed above illustrate some of the ways we do this.

May I take this opportunity to thank the Reverend Vernon, those involved in governance and the members of All Saints Church for their support and prayers; I look forward to your continuing support in the future.
